Chief Surgeon's Case Notes

I called a meeting of the Medical Board in August to deal with some issues. As a few of you know, DWNP lost its 501(c)(3) status a few years go. There is no reason to go into the hows or whys of it. We believe it was inadvertent. The Board discussed this issue in early 2012 and for a number of reasons tabled it. However, since then I noticed some difficulties dealing with other non-profits such as Rocky Mountain PBS, the Denver Museum of Nature and Science and public libraries. We are willing to help them but they are afraid that promoting us will endanger their 501(c)(3) status because we are not one. In addition, we have been talking about the possibility of sponsoring a Sherlock Holmes convention. As some of you know there have been an increasing number of them on the east and west coasts but none in this part of the country. Some of us think this would be fun. Some of our members already are involved in other local conventions and know people who run them. So there is a local knowledge base to tap into. But to host a convention you really need to be a 501(c)(3) non-profit. The Board voted to file to re-establish our 501(c)(3) status.

In order to do that we needed to make a change in DWNP's Colorado corporate registration. We also needed to amend our Bylaws to make them conform to the IRS requirements for 501(c)(3) non-profit and to make them conform to the current ways DWNP is run. We have done that. We have also filed 2013EZ with the IRS. We just need to wait for the determination letter.

The cost of re-establishing 501(c)(3) was \$500. The filing fee with IRS is \$400 plus \$100 fee which was paid to the state of Colorado. Bank balance was at \$643 at the date of the meeting. (More dues have been received since then.) \$300 of that was owed to Larry. Jennifer suggested a crowdfunding campaign to get the remaining funds, but we need to establish the 501(c)(3) status to legitimately ask for the funds. The consensus of the board was that we should restore 501(c)(3) status and seek contributions to cover that cost afterwards.


We made several changes to the Bylaws. (You can have a copy if you want one.) Mostly we simplified them. We removed duties that no one had followed in decades. We removed committees that never met. We changed the election process to voice votes *unless 5 members call for a secret ballot*. We allowed for one person to hold multiple offices. We clarified that a family membership gets only a maximum of 2 votes.

We did not increase the dues. This is the second time during my tenure that the Board has considered the issue and decided to maintain the dues at \$10 for a single member and \$15 for a family. However, we did create a new level of membership. This was inspired by the example of some members who donated amounts over the annual dues. Now people who donate \$50 or more per year will be Supporting Members, a status which carries some additional benefits. Supporting Members will receive a special certificate, acknowledgement at annual dinner, and a receive 25% discount on tickets to the annual dinner and other DWNP sponsored events, including a convention if we decide to sponsor one. When renewal notices are sent out at the end of the year they will include information about the new Supporting Member level.

Early next year we will start having meetings with members and non-members on about whether we want to host a Sherlock Holmes convention, and if so, what it will look like. We haven't yet chosen a name. Suggestions are welcome!

The Board also discussed issues of privacy and availability of members' contact information. We concluded that we need to ask the members. Rather than ask for a vote and let the majority rule, we have decided to give each member the option to make some or all of their information available to other members or the public. So the renewal notices will also include options on the release of your contact information.
